1. Definitions

- "Host Agency" means the applying organization that submits an application to host to the Sport Alliance of Ontario.

2. Time

- These Terms and Conditions shall be in effect for one year from the date of this letter.

3. Credit

- All advertising and program publicity associated with the Sport Safety Programs shall give credit to same, delivered through the Sport Alliance of Ontario.

4. Safe Environment

- All programs delivered through the Sport Alliance of Ontario shall be conducted so as to create a safe environment for all participants.

5. Limitation of Liability, Indemnification and Insurance

- The Host Agency agrees that the Sport Alliance of Ontario shall not be liable for any incidental, indirect, special or consequential damages, injury or any loss of use, revenue or profit of the recipient arising out of, or in any way related to the Sport Safety Programs.
- The Host Agency agrees that it shall indemnify the Sport Alliance of Ontario, their employees and agency, against all cost incurred as a result of a claim or proceeding related to the program.
- The Host Agency shall maintain comprehensive general liability insurance of at least \$1,000,000 per occurrence, for bodily injury (including personal injury), death, and damage to property, including loss of use thereof, and automobile liability insurance. If requested, the Host Agency shall provide satisfactory proof of such insurance. The Host Agency shall provide notice immediately upon change or cancellation of the insurance.

6. Policies and Procedures

- The Host Agency is responsible for understanding and following the Policies and Procedures outlined in the Host Agency Package for the Sport Safety Programs. This includes policies surrounding eligible expenses and the cancellation of a course or workshop if the minimum number of participants has not been met.

The undersigned, on behalf of and with the authority of the Host Agency, hereby agrees to abide by the above described terms and conditions governing the subsidy.
